Re: No reply from my 12/1 email and Melanie Vritschan my donations.

I have checked the payments and messages and as far as I could make out from my end the situation is the following:

1. You became a \$150 patron on 26 August 2018, see evidence attached. On the same day, I messaged you and asked you to let me know if and when you would like to make use of the private call that your patronage entitles you to. You acknowledged receipt of that message by replying to it, see evidence attached, but you did not request a meeting. Thus, I presumed that your patronage is donation only and you didn't want to use the private calls.

2. On 29 September you messaged me because you wanted to make a one-time donation. I replied the same day. At the time, you had still not requested a private call that you were entitled to through your patronage for the month of August. So again, I assumed that you were making contribution but didn't wish the call.

3. On 5th October, the notification of your first large donation came through. I acknowledged receipt and thanked you for it the same day, see evidence attached. You replied the next day on 6th October and stated that there are "Zero restrictions on the money, please use it for anything you want or need, to keep you as safe as possible.", again see evidence attached. By that time, the patronage has been deducted already for the month of September. Again, you didn't request a private call that you were entitled to through your patronage for the months of August and September.

4. Then I didn't hear from you until your message from 31 December 2018. The email you claim you've sent on 1st December 2018 does not appear in my inbox, see evidence attached which is a screenshot of how my messages appear today on 4th January 2019. I also note that in quoting your message from 1st December, you are not forwarding an email. I cannot see where that message is meant to have arrived or if it was even sent.

5. I also checked my Patreon account and there is no such message from you. The only message that appears on Patreon is the one I sent you on 23 November asking if you would like to arrange a private call, see evidence attached. Again, I didn't receive a reply from you. Therefore, I assumed that you didn't wish to use the private call that you were entitled to for the months of October and November either.

6. Regarding your donations, you contributed \$150 as a patron in September, October, November and December amounting to \$600 donations in total. Out of those, I have now refunded the months that I could refund over the platform, which is your donations deducted in October, November and December amounting to \$450. The donation for September I cannot refund via Patreon and as that donation of \$150 has already been used to cover my public interest work as stated as the purpose of those donations, there is no legal entitlement to refund it as far as I am aware. If there were, then charities could be bankrupted after the fact by large donors requesting their money back after the money has been spent as stated in the charities appeal for donations. However, you ARE entitled to a private call and I'm happy to arrange one for next week. Please let me know what day and time would suit you.

7. As mentioned above, you made two large donations via TransferWise of \$2000 and \$1000 in October 2018, see evidence attached. These are the donations that you have submitted with the statement "Zero restrictions on the money, please use it for anything you want or need, to keep you as safe as possible.". I therefore assumed that zero restrictions apply and I have ear marked those funds for my upcoming court case in England. You now made a request to transfer the money to someone else, namely Melanie Vritschan, which contradicts your original statement and also contradicts the fact that you donated the money to me and not to her charity ICATOR in Belgium. I cannot transfer the funds to Melanie Vritschan myself as I have cut ties with her and her organisation after money we raised on my YouTube channel from my audience in August and September was not used as agreed by her, which sabotaged the last scanning work at the Belgian university. I got in touch with TransferWise to enquire how to refund those payments to you so that you can donate them to her charity. As you converted the money into Euros, I can only refund what I received after the currency conversion, which might change the amount you receive due to fluctuations in the currency exchange rates.

8. Your statement "I believe you intentionally caused the legal problems for Melanie Vritschan, causing her to loose custody of her new born baby" is surprising and frankly hard to believe given that you decided to become a patron almost one year AFTER the events at Hospital Erasmus where Melanie Vritschan's baby was kidnapped by the doctors at the hospital. Nothing changed about the facts between 27 August 2018, when you donated to me for the first time and now, apart from Melanie using money we raised together on my YouTube channel to enable the work at the Belgian university that was intended to BENEFIT ALL VICTIMS for her own private utility bills and a bill for translating a document that she had already had translated and paid for in spring, as far as I am aware.

In summary, as far as I can make out, you have donated \$3600 via Patreon and TransferWise and not \$4500. If you think otherwise, please send me the receipt so that I can track down the payment with those companies. You also didn't request a private call during the months of September, October and November despite me enquiring several times. I have now refunded 3 out of 4 Patreon donations and I'm happy to arrange a call with you for the 4th, so please let me know what day and time would suit you next week or later. Your message that you claimed to have sent on 1st December hasn't arrived, nor can I make out where you have sent it. Your large donations are in the process of being refunded, I am just waiting for TransferWise to instruct me how to do that. You can then donate them to Melanie Vritschan.

Katherine, you caused the legal fees for Melanie, take some of the money I donated to you, for all the targeted individuals and pay all of Melanie Vritschan's legal fees.

Katherine, you put down the believers in Jesus Christ, god and the bible, which I am one. If I had known your true beliefs, what ever they are, you would not have gotten a cent from me.

Today I have stopped both of my monthly Patreon donations and I hope you keep your promise and share the donations I made to you with Melanie Vritschan. Pay all of her legal fees, you alone are solely responsible for.

I hope, with your testimony, they won't be able to sue Frederic...

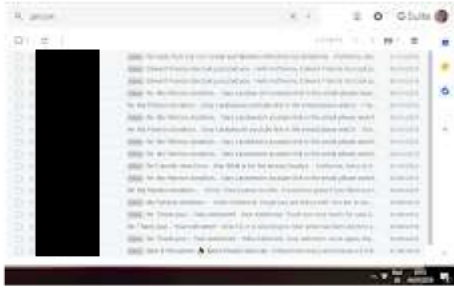
How could we handle the meeting or consultation?
